This installment plan agreement is between you and CM RESORT, LLC, a New Hampshire limited liability company (“Cranmore”). By signing this document, you agree as follows:

- You will pay the Balance Due (Box 3 above) for the season passes listed above in four equal installments with your credit card. The initial payment (Box 2 above) will be charged to your credit card upon Cranmore’s receipt of this signed agreement. The first installment will be charged to your credit card on June 15, 2021 and the final installment will be charged to your credit card on September 15, 2021. Your credit card statement for the installment charges will reflect one charge for all of the passes you purchase through this agreement.
- You will provide your credit card information with this agreement. **Debit cards are not accepted.** Cranmore will keep that information on file for the sole purpose of charging that card for the passes on the dates mentioned. The credit card you provide must have a valid expiration date through September 30, 2021. You authorize Cranmore to prepare and submit charge slips to your credit card for any transaction covered by this agreement to recover all charges and other unpaid amounts due.
- **You will contact the Cranmore Ticket Office immediately at 603-356-5544, ext. 241, if the credit card provided is lost or stolen, or if the credit card numbers or details change in any way. You will make payment for all amounts charged if the credit card provided expires or is invalid, or any of the charges are not paid by the credit card issuer.**
- Season passes are non-transferable and non-refundable. **You will not be entitled to your season pass, or the benefits provided under the season pass, until all installments payments have been paid in full.**
- Once you sign this agreement and deliver it to Cranmore, you acknowledge and accept full responsibility for these terms and guaranty payment for all of the season passes purchased. Cranmore may pursue all avenues of collection, including the use of collection agencies if you fail to pay.
- When picking up your pass(es), you agree to deliver to Cranmore a signed season pass waiver of liability form for each pass holder listed on the agreement. Adult pass holders will each sign a waiver and the parent or legal guardian of each minor pass holder will sign a waiver on behalf of that minor pass holder.
- This agreement is governed by New Hampshire law. Any claim or action involving parties or issues relating to or arising out of this agreement must be brought in the Superior Court of Carroll County, New Hampshire or the federal courts of New Hampshire. If any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect.
